# **Contest Rules & Regulations**

The Contest is governed by the rules set forth below. By entering the contest, you agree to abide by these rules and the decisions of the Contest Sponsor. You also agree to comply with all applicable laws.

## **Contest Period:**

Contest Start Date:	September 4, 2018 at 12:00am Mountain Daylight Time
Contest End Date:	November 30, 2018 at 11:59pm Mountain Standard Time

Entries must be received by the Contest Sponsor within the Contest Period in order to be eligible to win.

# **Entrant Eligibility**

- The Contest is open to legal residents of Alberta and Saskatchewan residents living within Lloydminster who are not employees, retirees or representatives of the Contest Sponsor or their respective affiliates, subsidiaries, related companies, agents, associates, dealers, representatives, advertising or promotional agencies or members of the immediate families of those employees and retirees or any persons with whom they are domiciled.
- Members under the age of 18 are eligible for the contest, however, in the event that the minor is chosen for the winning prize, parental consent and acceptance of the prize will be required.
- For the purpose of this Contest, "member of the immediate families" is defined as sibling, spouse, mother, father, grandparents, step-mother/father, brother, sister, son and/or daughter.
- The Contest Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in The Contest. Failure to provide such proof may result in disqualification.
- All personal and other information requested by and supplied to the Contest Sponsor for the purpose of The Contest must be truthful, complete, accurate and in no way misleading.
- The Contest Sponsor may at any time in their sole discretion disqualify any entrant who: does not meet the Contest eligibility criteria, fails to comply with these Rules & Regulations, attempts to enter The Contest in any manner or through any means other than as described in these Rules & Regulations, attempts to disrupt The Contest or attempts to circumvent any of these Rules & Regulations.
- Servus Credit Union reserves the right to suspend, disqualify, limit or revoke this Offer to any Member it finds or believes to be manipulating or otherwise abusing the process, fairness, or integrity of the Offer.
- Entries made with multiple addresses or under multiple identities during The Contest period are automatically void.

# How to Enter:

Investment in a Servus Credit Union financial product. Additional terms and conditions of the entry are as follows:

Investment into one of the following Servus Credit Union non-redeemable GIC products:

- 12-month,
- 18-month,
- 30-month

1 ballot per every \$1,000 of new funds invested into a qualifying GIC purchased, up to a maximum of 10 ballots per member.



# **Contest Rules & Regulations**

A Minimum investment amount of \$1,000 of new funds must be made into the below products to be entered into the contest:

 Non-Registered, Tax Free Savings, RRSP and RRIF non-redeemable 12-month, 18-month and 30-month GICs

All qualifying non-redeemable 12-month, 18-month and 30-month GICs sold between September 4 - November 30, 2018 will be entered into the contest.

The Double Your Money GIC rates are available on existing Servus Credit Union deposits up to a max of \$100,000 and new funds up to a max of \$5,000,000.

While existing Servus Credit Union deposits up to a max of \$100,000 will qualify for the rate special, they will not receive any ballots. Ballots are received on new funds only.

Contest available to Personal and Small Business memberships. Not available to Corporate/Institutional accounts.

Members will enter the contest via Servus Credit Union employee processing the investment. The Servus employee will enter product code specific to the eligible product(s). The product code and the campaign qualifying criteria will be used to pull a list of all eligible members at the end of the contest and a winner will be selected from this list.

The chances of winning are dependent on the number of entries received during the contest period.

Alternate Means - No purchase entry. To enter the contest, hand-print the contest name, your first name, last name, address, city, province, postal code, day and evening telephone numbers, the date of your request for a no purchase entry and mail in an envelope to: Servus Credit Union, Marketing Dept. 151 Karl Clark Road, Edmonton, AB, T6N 1H5. One entry will be made into the contest providing that the envelope is received bearing sufficient postage prior to The Contest closing date. The Contest Sponsor will not be responsible for any lost, delayed, misdirected, illegible, incomplete, damaged or undeliverable entries, or any delay or failure to transmit, process receive or consider entries. There is a maximum of one (1) entry per person for the alternate means of contest entry method. Contest is void where prohibited or restricted by law. The Contest is subject to all applicable federal, provincial and local laws and regulations.

# Prize(s):

There will be a total of 2 prize(s) consisting of:

Double your investment up to a maximum prize payout of \$10,000 on a winning eligible product purchase (12-month, 18-month or 30-month non-redeemable GIC).

Prizes will be randomly distributed throughout the Province of Alberta

The 1st Contest draw will be made on: November 5, 2018 at 12:00pm Mountain Standard Time

The 2nd Contest draw will be made on: December 5, 2018 at 12:00pm Mountain Standard Time

Servus branch or location the winner will redeem their prize:

The prize will be paid out into a non-registered GIC investment for a minimum period of 12 months. Interest pays upon maturity. Investments must be held to maturity\*. (Note: should the original GIC investment require redemption under the terms of Servus's hardship allowance, winnings and accrued interest on winnings will be forfeited.)



A Servus Credit Union representative will randomly select winner(s) from all eligible entries received during the Contest Period. The odds of being selected as a winner are dependent on the total number of eligible entries received. The winner will be verified and then contacted by a Servus Credit Union representative by telephone. In the event that the winner cannot be contacted within forty-eight (48) hours, despite customary diligent efforts, they will be disqualified and another winner chosen. The initial selected disqualified potential winner(s) will have no recourse toward the Contest Sponsor.

- If a potential winner cannot accept the Prize as awarded for any reason, his or her entry will be forfeited and another eligible entrant may be selected.
- Prize must be accepted as awarded and cannot be transferred to another person, substituted for another prize or exchanged in whole or in part for cash. The Contest Sponsor shall have no liability for any loss or damage resulting directly or indirectly from your participation in The Contest.

The Contest Sponsor is not responsible for: (1) incorrect or inaccurate transcription of entry information or late, lost, incomplete, misdirected entries, or entries received through impermissible or illegitimate channels; (2) technical failures of any kind, including without limitation the malfunctioning of any telephone, computer, network, hardware or software; (3) the unavailability or inaccessibility of any service; (4) unauthorized human intervention in any part of the entry process or the Contest; (5) electronic or human error which may occur in the administration of the Contest or the processing of entries; or (6) any injury or damage to persons or property, including without limitation your computer, which may be caused, directly or indirectly, in whole or in part, from your participation in the Contests. The Competition Sponsor will destroy all records containing personal information and/or render the personal information non-identifying so that it can no longer be used to identify any participant in The Contest, 24 months after The Contest close date.

In that event, the Contest Sponsor may award a prize at random from among the eligible entries received up to the time of the impairment, or cancel The Contest.

#### Disputes

All disputes, claims and causes of action arising out of or connected with the Contests, prizes or these Rules & Regulations will be resolved individually, without resort to any form of class action, and exclusively by the appropriate court of the Province of Alberta, Canada, in Edmonton, Alberta.

## Language Discrepancy
